PSB elections to commence in April

The election process for the Hypnotherapy and Healing Profession Specific Boards (PSBs) begin this month. Any registrant from Hypnotherapy and Healing can stand for election for the relevant PSB, including those who are currently members of the PSB. PSB members are elected by registrants to give CNHC registered practitioners a direct say in who will act as advisers to CNHC's Board.

Random Sampling 2018

As part of our duty as a voluntary regulator, CNHC carries out a random sampling on an annual basis to check insurance certificates and CPD logs of registrants. This involves CNHC asking 5% of registrants to send us copies of their insurance certificate and CPD log for their last full year of registration. This year's sampling will begin on Monday 7th May 2018 and the deadline to return documents will be Monday 4th June 2018.

If you are selected, you will be contacted by email and post to send us your completed CPD log and insurance certificate. If you need to update your contact details, you can do so by logging into MYCNHC. Please note that you are not required to send these documents unless you are notified that you have been selected as part of the random sample.

The full details of the policy and process for the sampling is available on our website <u>here</u>. If you are included in the sample, failure to comply could affect your registration. For further details about CNHC's CPD policy, visit our website here.



Kool to be Kind Initiative in Primary Schools



The Kool to be Kind initiative was designed to help children learn coping strategies if they got angry or frustrated at home or at school. Janice Barclay, CNHC registered Hypnotherapist, was contacted by Moray Firth Radio on behalf of their charity Cash for Kids to participate in this initiative.

The initiative started by identifying 3 local primary schools who were willing and eager to participate. They visited the children for up to a full day and worked with them in a group setting in their classrooms. Janice engaged with the children by asking them what they would do to be kind to someone, and while answering they got to cuddle a Care Bear. She then taught them about hypnotic anchors, so that if they ever felt insecure all they needed to do was take a deep breath and blow out their frustrations, and the lovely feeling of calm would return to them.

The sessions were a great success and many positive responses were received from the children and their teachers. Janice's registration with CNHC gave confidence to the charity and teachers for these initiatives, and she very much looks forward to working on more activities like these for her community.
